HOW TO USE THIS TABLE:

THE PROVIDER HSE TESTER ID AND PROVIDER HSE PASS DT COLUMNS CONTAIN HSE COMPLETER DATA SUBMITTED BY THE PROVIDER.

THE DIPLOMA SENDER HSE TESTER ID AND DIPLOMA SENDER HSE VENDOR COLUMNS CONTAIN THE SYSTEM OFFICE VERIFICATION OF THE PROVIDER-SUBMITTED DATA.

WHEN THE ROW IS **HIGHLIGHTED IN RED** AND THE DIPLOMA SENDER HSE VENDOR COLUMN DISPLAYS "NO HSE REPORTED", IT MEANS THAT THE SYSTEM OFFICE COULD NOT VERIFY THAT PROVIDER-SUBMITTED HSE RECORD.
